SERVICE AGREEMENT

1. I, hereby certify that my dog(s): is/are in good health and has/have not been ill with any communicable condition in the last 30 days. I also certify that my dog(s) have **all current vaccinations required by law** and do not show any signs of illness that may be contagious.
2. I further understand and agree that in admitting my dog(s) to the center, Dawgs All Day, LLC staff have relied on my representation that my dog(s) is in good health and has not harmed or shown aggression or threatening behavior towards any person or any dog.
3. Proof of updated vaccinations must be on file for my pet, which consists of Rabies, DHLPP and Bordetella. I also agree to administer heartworm and flea preventatives and consider having my dog receive the Influenza vaccine.
4. I further understand and agree that Dawgs All Day, LLC and their staff, will not be liable for any problems that develop, provided reasonable care and precautions are followed, and I hereby release care and liability of any kind whatsoever arising from my dog(s) attendance and participation at the center.
5. I further understand and agree that dogs can sometimes receive minor cuts and scratches at daycare. Any problems that develop with my dog(s) will be treated as deemed best by staff of Dawgs All Day, LLC at my sole discretion, and that I assume full financial responsibility for any and all expenses involved.
6. By leaving my credit card on file, I hereby authorize Dawgs All Day, LLC to charge my card for any services rendered at Dawgs All Day, LLC.
7. **RESERVATIONS:** We require a 24-hour reservation for any services in order to keep a calm and safe environment. We do recommend your dog participate in daycare a minimum of 4 times a month in order to acclimate them into our daily curriculum and activities. We also recommend your dog regularly scheduled grooming reservations in order to ensure smoother future grooming appointments.
8. **CANCELLATIONS:** We require cancellation notice due to space limitations.
9. **PICKUP & DROPOFF SERVICES:** Pickups are scheduled between 7am-8am weekdays only. Drop offs are scheduled between 6pm-7pm weekdays only. Reservations are required by 5pm same day. Prices vary per location. May be reserved same day without any additional fees except weekend daycare.
10. **FEES:** Services are paid in advance. \$25 Non Refundable deposit for FULL DAY assessments to be used on future services. *Early and late fees apply* for all services outside our regular operating hours. *Holiday fees* apply on all National Holidays. No refunds are issued. Credits will be placed on owners' accounts. *Daycare fees* apply to grooming reservations after the 2 hour time slot.
11. **DAYS AND HOURS:** Monday-Friday from 7:00a.m to 7:00 p.m. (RETAIL CLOSED 12pm to 3pm) and Saturday from 9:00a.m to 7:00p.m. Sunday-CLOSED
12. Dawgs All Day, LLC, agrees to exercise due diligence and reasonable care for your pet in a sanitized and properly enclosed facility. DAD is dedicated in providing a fun and safe environment for you and your pet and will take reasonable and necessary precautions to ensure the security of all DAD guests.
13. I also understand and agree the risk involved in "free play" and accept that some injuries may result from such interactions in admitting your dog for Grooming, Daycare and/or Boarding to DAWGS ALL DAY, LLC. The DAD staff reserves the right to treat such injuries onsite or have the pet seen by a veterinarian if injuries require such care. All costs relating to veterinary care shall be paid by the owner and DAD shall be reimbursed promptly for any advances made for such injuries that occurred.
14. **DAD reserves the right to refuse any pet.**
15. Owner agrees their pet may be videotaped, photographed and recorded, such materials will be used in any and

all media, promotion and advertising of DAD, LLC

16. I hereby agree to waive and release Dawgs All Day LLC. and their employees from any liability from medical payments, bodily injury damages, or property damages regardless of the cost, as a result of any injury resulting from the actions of my dog, any other dog, or any humans while in the facility or on daily walks.
17. I am aware any dog left at Dawgs All Day, LLC after 30 days is considered neglect and the dog will be released to local animal rescues for the processing of adoption. I will be billed for the dog's daycare and boarding expenses and will be followed with proper collection processes as deemed necessary.
18. I, hereby waive and release Dawgs All Day, LLC, its employees, owners and agents from all liability for injury or damage which I or my dog may suffer as a result of the pet grooming process.
19. I have disclosed any and all known dangers associated with my pets, including behavioral issues that may impact the safety of the grooming staff as well as the safety of my pet at Dawgs All Day, LLC.
20. I hereby grant permission to Dawgs All Day, LLC to obtain emergency veterinary treatment for my pet, at my expense. For my pet's benefit, Dawgs All Day, LLC will use the services of the nearest veterinarian.
21. I understand pet grooming can expose a hidden medical problem or aggravate a current one. This can occur during or after grooming.
22. I understand that Dawgs All Day, LLC does NOT recommend shave downs except when medically necessary or when pet is so severely matted that in our professional opinion the Matts cannot be combed or brushed out without causing the pet unnecessary discomfort and distress.
23. I am aware that the shave down process makes use of electric clippers that may leave the pet's coat no longer than 1/16" and authorizes us to "shave down" the pet.
24. I am aware that after being shaved down, my pet may require sunscreen in order to prevent sunburn.
25. I am aware that these procedures may have unpleasant consequences such as clipper burn, nicks or cuts. Dawgs All Day, LLC will use all precautions during these procedures but will not be held responsible for aforementioned side effects.
26. I understand senior pets have an increased risk of injury and/or stress while grooming.
27. I certify that my unspayed female brought for grooming is at least two weeks out of her most recent heat.
28. Dawgs All Day, LLC will exercise all necessary precautions during the grooming process, but I am aware that if my pet is matted, it may be necessary to shave or dematt my pet, and that these procedures may have unpleasant consequences such as clipper burn, brush burn or nicks and cuts and incur additional fees.
29. Dawgs All Day, LLC will use all precautions during these procedures but will not be held responsible for the aforementioned side effects.
